Operation


The YJM 308 Overdrive Preamp is the sound of a guitar hitting raw distortion. The controls are straight forward:

Gain: Adjusts the amount of distortion

Level: Adjusts the overall volume.

The **switch** engages or disengages the distortion.

Changing the Battery

1. Remove the back plate screws.
2. Remove and replace the battery.
3. Replace back plate and screws

Note: To prolong battery life, unplug the input jack when not in use.
